

# 130+ ARMSTRONG TEASDALE LAWYERS NAMED AMONG 2025 BEST LAWYERS<sup>®</sup>, ONES TO WATCH

Armstrong Teasdale announces that more than 130 lawyers have been listed among The Best Lawyers in America<sup>®</sup> and Ones to Watch – 2025 edition. The lawyers were ranked across nearly 60 practice areas and 11 offices.

Best Lawyers recognitions are based entirely on peer review to capture, as accurately as possible, the consensus opinion of leading lawyers about the professional abilities of their colleagues within the same geographical region and legal practice area.

Fifty-two lawyers are ranked in the Ones to Watch category, which features up-and-coming lawyers in earlier in their careers. Of those, 13 are ranked for the first time.
